ISA LEADERSHIP SENDS LETTER TO GOVERNOR REYNOLDS

In May, the Iowa Seed Association leadership sent a letter to Iowa Governor Kim Reynolds and Iowa Secretary of Agriculture Mike Naig in regards to farm labor and migrant worker testing. Taking a proactive role, ISA leadership is ensuring that farm laborer's in Iowa are safe while also ensuring that there is adequate supply of healthy workers for the important tasks of detasseling corn, etc.

It is our understanding is that ASTA is also taking an active role in this as well. As a member, if you feel like there is something that we can do to work with ASTA on this, please reach out. Leadership is continuing to communicate to our member seed companies the importance of following our local state guidelines on this.

The letter states, "On behalf of the Iowa Seed Association (ISA) board of directors, we would like to express our support of our member companies and their workers that will be undertaking corn detasseling work as well as other farm labor this summer amid the challenges of Covid-19.

Each year, seed companies hire both local workers and migrant workers from outside the United States to work in

their seed corn production fields. We feel that the safety of those workers as well as the local communities that house them is critical. As such, we would like to share with you that the ISA and its members are doing everything we can to follow the guidelines set forth by Iowa Workforce Development and the Iowa Department of Public Health."

The letter, signed by ISA president, states, "One potential issue that we could use some guidance on is the accessibility of Covid-19 testing for incoming workers. Current plans that we have seen from travel companies call for temperatures to be checked prior to migrant workers coming to lowa from Mexico. Also, temperatures will be checked upon arrival as well. However, we would like to remove any potential roadblocks that migrant workers might have in getting tested quickly if they develop symptoms while here."

EPA ISSUES CANCELLATION AND EXISTING STOCKS ORDER FOR DICAMBA PRODUCTS

The Environmental Protection Agency issued has cancelledthe label for Xtendimax with Vaporgrip Technology (EPA Reg. No. 524-617), Engenia – (EPA Reg. No. 7969-345), and FeXapan – (EPA Reg. No. 352-913). The cancellation order outlines limited and specifi c circumstances under which existing stocks of the three aff ected dicamba products can be used for a limited period of time.

Details of the Order

EPA's order addresses sale, distribution, and use of existing stocks of the three aff ected dicamba products. Distribution or sale by any person is generally prohibited except for ensuring proper disposal or return to the registrant. Growers and commercial applicators may use existing stocks that were in their possession on June 3, 2020, the eff ective date of the Court decision. Such use must be consistent with the product's previously-approved label, and may not continue after July 31, 2020.

The cancellation and existing stocks order is consistent with EPA's standard practice following registration invalidation, and is designed to advance compliance, ensure regulatory certainty, and to prevent the misuse of existing stocks.

Members with staff who need commercial pesticide applicator certification are encouraged to take full advantage of the drive-up testing option. NEW PROGRAM HELPING APPLICATORS KEEP FIELD WORKERS SAFE

Sieldcheck[®] By FieldWatch

Pesticide applicators in Iowa can now know in near real-time where seed field workers are active. Those registered with the FieldWatch system through the state of Iowa as an applicator now have access to SeedFieldCheck reporting, which shows where field workers are currently active and where seed companies plan to have active workers in the following 24 hours.

The new functionality is integrated into the existing FieldWatch crop and apiary registry. It will help seed companies more effectively communicate the location and presence of seed field workers to pesticide applicators. The information will be available in near real-time allowing seed companies the ability to make edits and update plans quickly and replace the endless circulation of emails and paper or electronic maps to targeted applicators. With the addition of seed field workers to the FieldWatch system, the state of Iowa has a "one-stop-shop" for applicators to find information about sensitive crops, apiaries, and seed field workers.

SeedFieldCheck is a pilot project launched in the state of lowa by the lowa Seed Association, lowa Agricultural Aviation Association, and FieldWatch®.

ISA encourages all commercial applicators to register with FieldWatch®. Companies and pesticide applicators who are currently registered with FieldWatch® will need to specifically add the SeedFieldCheck capability. This will allow a full report of sensitive crops, apiaries, and active field workers to registered users.

Companies currently participating in reporting field workers include Bayer, Becks, Corteva, Remington Seeds, and Syngenta.

COVID-19 GUIDANCE FOR AGRICULTURE EMPLOYERS

Farming is an essential business operation and activity, often supported with the use of migrant and seasonal farm workers. COVID-19 can spread rapidly in settings with many people living in close proximity, including living facilities for migrant farm workers. Agriculture employers and farm labor contractors who provide housing for migrant workers should implement plans to prevent exposure to the virus that causes COVID- 19, care for individuals with COVID-19, and prevent community transmission of the disease. Commitment to strong sanitary protocols will decrease operational impacts.

Who this guidance is for: All agriculture workers and their employers. Farm operations vary across regions of

the country. This guidance provides a template of action to protect agriculture workers from coronavirus disease 2019 (COVID-19). Agricultural employers can adapt these recommendations to protect workers at their particular work sites or in specific work operations.

Purpose: Agriculture work sites, shared worker housing, and shared worker transportation vehicles present unique challenges for preventing and controlling the spread of COVID-19. Consistent application of specific preparation, prevention, and management measures can help reduce the risk of spreading COVID-19.
